SUMMARY OF SIGN INVENTORY

This report was conducted at the request of the Mirada Community Development District (CDD) to document the deficiencies of the existing signs at the intersection of Setter Palm and Mirada Blvd.

A total of 2 signs did not meet the minimum height requirement (sign number 2 and 8) and 1 did not meet the roadway offset requirement (sign 6).

This report includes a field inventory of the signs within the community to determine their compliance with the guidelines of the 2009 Edition of the MUTCD.


Section 2A.18 Mounting Height

Standard:

⁰⁵ The minimum height, measured vertically from the bottom of the sign to the top of the curb, or in the absence of curb, measured vertically from the bottom of the sign to the elevation of the near edge of the traveled way, of signs installed at the side of the road in business, commercial, or residential areas where parking or pedestrian movements are likely to occur, or where the view of the sign might be obstructed, shall be 7 feet (see Figure 2A-2).

Option:

⁰⁶ The height to the bottom of a secondary sign mounted below another sign may be 1 foot less than the height specified in Paragraphs 4 and 5.



*Where parking or pedestrian movements are likely to occur

Section 2B.03 Size of Regulatory Signs Standard:

Except as provided in Section 2A.11, the sizes for regulatory signs shall be as shown in Table 2B-1.

Section 2B.10 STOP Sign or YIELD Sign Placement

Guidance:

or STOP or YIELD signs should not be placed farther than 50 feet from the edge of the pavement of the intersected roadway Guidance:

⁰⁸ A sign that is mounted back-to-back with a STOP or YIELD sign should stay within the edges of the STOP or YIELD sign. If necessary, the size of the STOP or YIELD sign should be increased so that any other sign installed back-to-back with a STOP or YIELD sign remains within the edges of the STOP or YIELD sign.

12 Stop lines that are used to supplement a STOP sign should be located as described in Section 3B.16.
Yield lines that are used to supplement a YIELD sign should be located as described in Section 3B.16.
13 Where there is a marked crosswalk at the intersection, the STOP sign should be installed in advance of the crosswalk line nearest to the approaching traffic.

Section 2B.13 Speed Limit Sign (R2-1) Standard:

⁰² The Speed Limit (R2-1) sign (see Figure 2B-3) shall display the limit established by law, ordinance, regulation, or as adopted by the authorized agency based on the engineering study. The speed limits displayed shall be in multiples of 5 mph.

Section 3B.16 Stop and Yield Lines

Guidance:

on Stop lines should be used to indicate the point behind which vehicles are required to stop in compliance with a traffic control signal.

Option:

⁰² Stop lines may be used to indicate the point behind which vehicles are required to stop in compliance with a STOP (R1-1) sign, a Stop Here For Pedestrians (R1-5b or R1-5c) sign, or some other traffic control device that requires vehicles to stop, except YIELD signs that are not associated with passive grade crossings.

⁰⁶ Stop lines shall consist of solid white lines extending across approach lanes to indicate the point at which the stop is intended or required to be made.

Guidance:

08 Stop lines should be 12 to 24 inches wide.

10 If used, stop and yield lines should be placed a minimum of 4 feet in advance of the nearest crosswalk line at controlled intersections, except for yield lines at roundabouts as provided for in Section 3C.04 and at midblock crosswalks. In the absence of a marked crosswalk, the stop line or yield line should be placed at the desired stopping or yielding point, but should not be placed more than 30 feet or less than 4 feet from the nearest edge of the intersecting traveled way.

INVENTORY

All existing signage were photographed and inventoried with designations of sign type, size, height and offset to edge of sign from the curb. These conditions were compared to the MUTCD minimum requirements previously mentioned to determine compliance and need to adjust/replace the regulatory signs. Below is an inventory of the signage reviewed at the intersection of Mirada Blvd. and Setter Palm Drive.





